CEASE AND DESIST ORDER

On August 25, 2014, the Texas State Board of Dental Examiners ("Board") proposed this Cease and Desist Order against ARNULFO GONZALEZ.

The Board has received information and possesses certain evidence indicating that Arnulfo Gonzalez (hereinafter as "Respondent") has violated provisions of the Dental Practice Act (the Act), codified at Tex. Occ. Code §§ 251 through 257.

Failure to file a written request for a hearing on this Order prior to September 15, 2014, will render this Order immediately effective and non-appealable in accordance with Tex. Occ. Code § 264.0525(b).

Pursuant to authority granted at Tex. Occ. Code § 264.0525, the Board finds and issues the following:

FINDINGS OF FACT


1. During the time period from October 29, 2012, through July 7, 2013, Respondent practiced dentistry without a license and illegally owned a dental office, ConGo Dental Clinic, P.C., at 7005 Pastor Bailey Drive, Suite 103-B, Dallas, Texas 75237. Respondent employed a dentist to provide dental services at this location. Additionally, tax records and filings with the Secretary of State show Respondent to be the owner of the dental office. This conduct is in violation of Tex. Occ. Code §251.003(a)(4).

ORDER

IT IS THEREFORE ORDERED THAT:

Arnulfo Gonzalez, **CEASE AND DESIST** from any further action in the state of Texas in connection with the unlawful practice of dentistry.
