CEASE AND DESIST ORDER

On April 12th, 2016, the Texas State Board of Dental Examiners (Board) proposes this Cease and Desist Order against O'Neal Affordable Dentures; James E. O'Neal; and Victoria O'Neal (O'Neal Affordable Dentures).

The Board has received information and possesses certain evidence indicating that O'Neal Affordable Dentures has violated provisions of the Dental Practice Act (the Act), codified at Texas Occupations Code, Title 3, Subtitle D.

Failure to file a written request for a hearing on this Order prior to May 5, 2016 will render this Order immediately effective and non-appealable in accordance with Texas Occupations Code § 264.0525(b).

Pursuant to authority granted under Texas Occupations Code § 264.0525, the Board finds and issues the following:

FINDINGS OF FACT

1. During the time period from April 10, 2014, through July 30, 2015, O'Neal Affordable Dentures unlawfully practiced dentistry without a license. Specifically, O'Neal Affordable Dentures:
 - a. Made, processed, reproduced, repaired, and relined full and partial dentures without a written prescription or work order signed by a dentist legally practicing in this state or any other jurisdiction; and
 - b. Represented that they were denturists or used another title that is intended to convey to the public that the services offered by the person are included within the practice of dentistry.
2. The conduct described above is a violation of Texas Occupations Code §§ 251.003(a)(7)(A), (10); 256.001; 266.155(b).

ORDER

IT IS THEREFORE ORDERED THAT:

O'Neal Affordable Dentures, **CEASE AND DESIST** from any further action in the state of Texas in connection with performing or offering to perform dentistry for any person in the state of Texas.
