

CEASE AND DESIST ORDER

On March 15, 2013, the Texas State Board of Dental Examiners ("Board") proposes this Cease and Desist Order against JUANJIN CHEN.

The Board has received information and possesses certain evidence indicating that JUANJIN CHEN has violated provisions of the Dental Practice Act (the Act), codified at Tex. Occ. Code §§ 251 through 257.

Failure to file a written request for a hearing on this Order prior to April 15, 2013 will render this Order immediately effective and non-appealable in accordance with Tex. Occ. Code § 264.0525(b).

Pursuant to authority granted at Tex. Occ. Code § 264.0525, the Board finds and issues the following:

FINDINGS OF FACT

1. On or about March 11, 2013, JUANJIN CHEN engaged in the unlawful practice of dentistry in the state of Texas. This conduct is a violation of Tex. Occ. Code § 256.052 and may be subject to criminal prosecution.
2. On or about March 11, 2013, JUANJIN CHEN was arrested and charged with practicing dentistry without a license in Harris County, Texas.

ORDER

IT IS THEREFORE ORDERED THAT:

JUANJIN, **CEASE AND DESIST** from any further action in the state of Texas in connection with the unlawful practice of dentistry.



CEASE AND DESIST ORDER

On March 15, 2013, the Texas State Board of Dental Examiners ("Board") proposes this Cease and Desist Order against YUE KANG, INC, DBA WEL CARE DENTAL ("WEL CARE").

The Board has received information and possesses certain evidence indicating that WEL CARE has violated provisions of the Dental Practice Act (the Act), codified at Tex. Occ. Code §§ 251 through 257.

Failure to file a written request for a hearing on this Order prior to April 15, 2013 will render this Order immediately effective and non-appealable in accordance with Tex. Occ. Code § 264.0525(b).

Pursuant to authority granted at Tex. Occ. Code § 264.0525, the Board finds and issues the following:

FINDINGS OF FACT

1. Yue Kang, Inc. is a domestic for-profit corporation, which was registered with the State of Texas on February 5, 2011.
2. Yue Kang, Inc. has an address of record at 9198 Bellaire, Suite B, Houston, TX 77036, and an alternate address of 6200 Savoy Drive Ste. 700, Houston, Texas 77036.
3. Yue Kang, Inc. is owned and directed by Yuanjin Chen.
4. Yue Kang, Inc. has a registered assumed name of "Wel-Care Dental"
5. Wel-Care Dental is owned and operated by an individual who is not a licensed dentist.
6. On or about March 11, 2013, Juanjin Chen engaged in the unlawful practice of dentistry at the Wel-Care Dental location at 9198 Bellaire, Suite B, Houston, TX 77036. This conduct is a violation of Tex. Occ. Code § 256.052 and may be subject to criminal prosecution.
7. On or about March 11, 2013, Juanjin Chen was arrested and charged with practicing dentistry without a license in Harris County, Texas.

ORDER

IT IS THEREFORE ORDERED THAT:

Yue Kang, Inc. DBA Wel-Care Dental, **CEASE AND DESIST** from any further action in the state of Texas in connection with the unlawful practice of dentistry.
